

Deferment application form

This form is to be used by local and international students who have been made an offer for a course at Monash University Malaysia and wish to defer their enrolment for that course.

If you are currently enrolled in a course at Monash and wish to take a period of leave, you should complete an Intermission application form.

International students who wish to defer the offer of their place must contact the International Students Services Unit for advice.

Deferment

In most cases if you are deferring the offer of your course, you may do so for a period of up to twelve months at the discretion of the enrolling faculty.

You are not normally permitted to defer an offer for a Monash course with the intention of undertaking studies at another institution in Malaysia or overseas during the period of deferment.

If you wish to undertake studies at another institution during the period of deferment, you are advised that credit will not be granted towards the Monash degree unless the study was approved by the enrolling faculty at Monash as part of the deferment conditions.

You should consult your enrolling faculty for further advice on this matter.

Closing dates

Applications for deferment must be received by the start of the semester. If you do not submit an Application for deferment prior to the semester start date, you risk losing your place in the offered course.
